[FINAL JUDGMENT]

On May 9, 2011, this cause came to trial. All parties were represented by counsel. On May 11, 2011, at the conclusion of Plaintiff's case and evidence, the defendants Karen McGraw, Faye Rogers, R.N., and Living Centers East, Inc. d/b/a Fairview Health and Rehabilitation Center moved for Judgment as a Matter of Law as to all of Plaintiff's claims.

At that time, Plaintiff voluntarily dismissed the defendants Karen McGraw and Faye Rogers, R.N., leaving Living Centers East, Inc. d/b/a Fairview Health and Rehabilitation Center as the only remaining defendant.

Having considered Defendant's motion and the oral arguments of the parties, the Court **FINDS** that said motion is well taken.

Accordingly, Defendant Living Centers East, Inc. d/b/a Fairview Health and Rehabilitation Center's Motion for Judgment as a Matter of Law is hereby **GRANTED**. All of Plaintiff's claims against said defendant are **DISMISSED, with prejudice**, and shall not be submitted to the jury. This dismissal disposes of all of Plaintiff's claims. Costs are taxed as paid.
